CITY ATTORNEY REPORT ON CLOSED SESSIONS

City Attorney Geuss announced that on October 6, 2015, in the matter of City of Riverside v. Jurupa Community Services District, the City Council unanimously approved a settlement proposal that later became final with the following terms: (1) Jurupa Community Services District will pay the City \$15 million within 90 days. In exchange, Jurupa Community Services District will receive an additional one million gallons per day of sewer capacity beginning in the Year 2030; (2) Should Jurupa Community Services District need additional capacity prior to the Year 2030, they will pay a surcharge; (3) Jurupa Community Services District will pay up to \$287,500 for the first ten years toward capital improvements for years 2011 through 2020; (4) Jurupa Community Services District will contribute up to \$400,000 towards capital improvements prior to the year 2020; (5) the parties will negotiate the annual amount toward capital improvements; and (6) any disputes will be handled through arbitration.
