Chair Jackson opened by asking Commissioners to give their opinions on the items in the "Areas of Concern" document.

Discussion began with Commissioners commenting on the items they felt should be included in the Commission's letter to Chief Diaz. As discussion continued, a recommendation was made that it would be more appropriate to submit formal policy recommendations rather than just a letter of concern. Discussion then focused on whether a letter of concern or formal policy recommendations would be best.

After considerable discussion, Commissioner Ybarra made a motion that the Commission submit formal policy recommendations to RPD regarding the items noted in the document under discussion. The motion was seconded by Vice-Chair Adams. Unanimous approval.

Chair Jackson, Vice-Chair Adams, and Mr. Hauptmann said they would work together to draft the policy recommendations.

Hayes Officer-Involved Death (OID) Case Evaluation

Continue discussion and action, if any, on the Hayes OID Case Evaluation. The Commission may return to discussion of completed Stages, if needed.

F) Stage VI – Written Public Report: In Process

Chair Jackson opened for discussion of the public report.

During the discussion, it was noted that there were redundancies in Section IV and Section VIII. Discussion concluded that Paragraphs 1 – 5 be deleted from Section VIII and that Paragraphs 6 and 7 be moved to the end of Section IV. Section VIII would then consist of Paragraphs 8 and 9.

It was also noted that the RPD Use of Force Policy shown in Section VII should have been Policy 4.30 rather than Policy 300 as Policy 4.30 was active at the time of the OID.

Commissioner Rotker made a motion that the Commission approve the Hayes Public Report, with the noted changes and corrections. The motion was seconded by Vice-Chair Adams. Unanimous approval.

Ramirez Officer-Involved Death (OID) Case Evaluation
