4. BOARD AND COMMISSION ATTENDANCE POLICY

Deputy City Attorney Rina Gonzales presented the item to the Commission. She informed them that each Board and Commission is being asked to update their Standing Rules to incorporate the Attendance Policy approved by City Council on May 6, 2014.

After discussion, a motion was made to update the Park and Recreation Standing Rules to incorporate the Board and Commission Attendance Policy stating, "Board/Commission members shall make every effort to notify the Chairperson or his/her designee no later than 24 hours prior to any regular meeting of his/her intent not to attend said meeting. A member's inability to provide 24 hours advance notice shall not preclude the Board/Commission from exercising its discretion to excuse said absence as outlined in Section 805 of the City Charter."
