<b>HOMELESSNESS CONCERNS ALONG SANTA ANA RIVER</b>							
Following discussion, it was moved by Councilmember Melendrez and seconded by Councilmember Johnston directing the City Managers to (1) convene a joint team to meet monthly to coordinate efforts regarding homelessness concerns along the Santa Ana River with quarterly reports to each City Council; and (2) create a joint website for public education. Motion carried unanimously.							
<b>POTENTIAL RECREATIONAL OPPORTUNITIES FOR SANTA ANA RIVER</b>							
Following discussion of potential recreational opportunities for the Santa Ana River, it was moved by Councilmember Gardner and seconded Councilmember Berkson directing the City Managers to coordinate a Joint Santa Ana River Day. Motion carried unanimously.
