Approval of Minutes

A) January 27 Regular Meeting

A motion was made by Vice-Chair Adams to approve the Minutes of January 27, 2016. The motion was seconded by Commissioner Ybarra. Seven approved; Commissioner Andres abstained.

 Discussion and action, if any, to approve the Commission's recommendations resulting from its
 review of the Jimenez Officer-Involved Death case.

Chair Jackson opened with discussion of the policy recommendations. Commission consensus was that General, #5, be removed as RPD had addressed the issue that all officers carry Tasers. After additional minimal discussion, Commissioner Hawkins made a motion to accept the Jimenez Policy Recommendations with the noted change. The motion was seconded by Commissioner Andres. Unanimous approval.

Chair Jackson then opened discussion of the Public Report. After minimal discussion, Commissioner Ybarra made a motion to approve the Jimenez Public Report with the removal of General, #5, in the Recommendations section. The motion was seconded by Vice-Chair Adams. Unanimous approval.

Ramirez Officer-Involved Death (OID) Case Evaluation

Chair Jackson opened by asking for discussion of the Public Report. There was none.

A motion was made by Commissioner Hawkins to approve the Ramirez Public Report. The motion was seconded by Commissioner Ybarra. Unanimous approval.

Chair Jackson advised Commissioners that the Jimenez and Ramirez OIDs were now ready for the Admin review and that they would be advised when the casebooks were available.

Chair Jackson opened by asking for discussion of the case. As Commissioner Rotker arrived during the discussion, Chair Jackson moved back to Item 2.

Chair Jackson then returned to discussion of the Martinez OID.

After additional brief discussion, a motion was made by Commissioner Hawkins finding that the actions of Officer Marco Ortiz were Within Policy. The motion was seconded by Commissioner Andres. Unanimous approval.

Chair Jackson asked Commissioners to submit their rationales to Staff by March 7th and asked Mr. Hauptmann about the Fact Sheet and Public Report. Mr. Hauptmann said they would be ready for the March meeting.

ONGOING COMMISSION ACTIVITIES & ISSUES

Annual CPRC Officer Elections – March 2016

Elections for the CPRC Chair and Vice-Chair will take place during the first meeting in March. Commissioners interested in serving as Chair or Vice-Chair can inform the Commission of their interest or can nominate a fellow Commissioner. Nominations for Chair and Vice-Chair may be made during the February Regular Meeting. Those who are nominated by a fellow Commissioner must accept or decline the nomination.

Chair Jackson opened by calling for nominations for Chair and Vice-Chair.

Commissioner Smith nominated Vice-Chair Adams for Chair. Commissioner Roberts nominated Commissioner Hawkins for Vice-Chair and Commissioner Andres nominated Commissioner Smith for Vice-Chair. All nominations were accepted.

Chair Jackson advised that the elections would be the second item on the agenda and that nominations could be made at the March meeting.

2015 Annual Report

Discussion and action, if any, on Draft No. 3 of the 2015 Annual Report.

Chair Jackson opened and turned the item over to Vice-Chair Adams, Chair of the Annual Report Ad-hoc Committee.

Vice-Chair Adams said that the Committee would meet one more time to finalize the report for approval at the March meeting. Chair Jackson said the Chair's Message had been submitted and Ms. Sherron advised that the only things left to be done were adding photos and updating the Outreach section.

Commissioners were asked to submit or update their bios as soon as possible along with reviewing the report prior to the March meeting.

CPRC Self-Assessment Project

Continuation of self-assessment project regarding the Commission's effectiveness and its potential for improvement.

Chair Jackson opened the item by asking for suggestions on groups that could provide a critique of the Commission. Commissioner Smith suggested RCPA as well as Chief Diaz and his Command Staff. Commissioner Smith also suggested drafting a questionnaire that could be provided to the various groups and ask each for their top three recommendations.

Suggestions regarding groups were RCPA, Chief Diaz and his Command Staff, neighborhood watch groups, community action groups, NAACP, The Group, The Latino Network, The League of Women Voters, and LULAC.

Commission Goals for 2016

Discussion and action, if any, regarding the Commission's goals for 2016.

Chair Jackson said she would like a Spanish version of the CPRC brochures. Commissioner Smith suggested improvement of the community footprint with an increased individual presence in Commissioners' specific wards and to make YouTube video of the CPRC Outreach presentation. Vice-Chair Adams recommended meeting with the DA and RPD regarding the length of time it takes to get OID case information and complaints.

- **A)** Outreach Committee: Vice-Chair Adams, Committee Chair Vice-Chair Adams liked Commissioner Smith's suggestion about the Outreach Committee being involved with the Self-Assessment Project. She had no Committee activities to report.
- **B)** RPD Outreach Committee: Commissioner Rotker, Committee Chair Commissioner Rotker reported that he and Chair Jackson met with Internal Affairs on February 5th. Chair Jackson said IA gave an excellent presentation and that she and Commissioner Rotker felt IA should make a presentation to the entire Commission.

Chair Jackson asked Mr. Hauptmann if he had been able to get dates for a meeting with the Command Staff and RPOA. Mr. Hauptmann said he would check with Capt. Gonzalez when he returned to Riverside and noted that the RPOA Board meets Tuesday, Wednesday, and Thursday mornings.

C) 2015 Annual Report Committee: Vice-Chair Adams, Committee Chair Vice-Chair Adams said she would schedule a meeting to review the final draft of the report.

NEW COMMISSION ACTIVITIES & ISSUES

Letter of Commendation

Discussion and action, if any, to approve the Letter of Commendation regarding Officer Shadee Hunt.

Chair Jackson opened the item for discussion. There was discussion as to whether or not the Commission should send Letters of Commendation. While many felt that Officer Hunt acted very commendably, they also argued that if one officer was commended for his or her actions during an officer-involved death incident, others should be, too. It was also suggested that before any Letters of Commendation are sent, guidelines should be created.

After considerable discussion, a motion was made by Commissioner Hawkins to rescind the Letter of Commendation to Officer Hunt. The motion was seconded by Commissioner Andres. Seven approved rescinding; Vice-Chair Adams and Commissioner Smith voted against the motion.

Potential Letter of Commendation

Discussion and action, if any, on whether a Letter of Commendation should be drafted for Officer Nathan Asbury who was involved in the Hayes OID.

Chair Jackson opened the item for discussion and turned the item over to Commissioner Rotker as he had asked that it be agendized. Commissioner Rotker withdrew his request as the letter for Officer Hunt had been rescinded.

PowerPoint Training

Discussion and action, if any, regarding

- A) The training of Commissioners in the setup and operation of PowerPoint at various venues;
- **B)** The selection of a trainer / trainers;
- **C)** The best method by which the training can be accomplished.

Chair Jackson opened the item by noting that she and Commissioner Rotker realized that some Commissioners might need training in the setup of hardware and operation of PowerPoint. She then asked for a volunteer to do the training. Commissioner Smith said he would volunteer to train and said he would advise Chair Jackson, Vice-Chair Adams, and Staff of various methods of training.

Chair Jackson suggested agendizing the rearranging of Committee chairs. It was suggested that perhaps the Outreach Committee should be made a standing committee. Vice-Chair Adams recommended that the Committee meet before that change is made.

Adjournment

Chair Jackson noted that Commissioners needed to submit rationales for Martinez by March 7th, the Martinez Fact Sheet and Public Report by March 11th. She said that questions regarding CPRC Officer Elections should go the Mr. Hauptmann and asked Mr. Hauptmann about scheduling CPRC training by the DA's Office and Internal Affairs.

The Commission was then adjourned at 7:50 PM.
