## CALL TO ORDER

During public comment, one speaker addressed the Commission. Les Twedell commented on a possible dog corral at Ryan Bonaminio Park and the need for more signage and trash receptacles; he gave Commissioners a map of his proposed project.

Chairperson Whatley read a letter from Rudy Chavez representing the Concerned Citizens of Casa Blanca regarding the pending Lara naming request.

#### 4. UPDATES ON THE DEPARTMENT'S PARK MASTER PLAN AND RYAN BONAMINIO PARK AT THE TEQUESQUITE ARROYO

Director Cruz gave a brief update on the item and presented Principal Park Planner McDaniel to present the PowerPoint.

Chairperson Whatley inquired if the Master Plan will be a lined budget item and if it will overlap with the 2.0 Needs Assessment Project.

Director Cruz clarified the Master Plan project was requested in the current budget cycle and staff is exploring options with the Legal Department to see if Regional Park Funds can be used.

Deputy Director Lara confirmed that Master Plan update and Riverside 2.0 Deferred Maintenance Needs Assessment Projects may overlap but are two distinct projects.

Chairperson Whatley stated she would like to be able to provide input and recommendations as Commissioners to their Councilmembers.

Commissioner Cardullo asked how the Master Plan will be prioritized.

Principal Park Planner McDaniel explained the community input process and confirmed safety will always be addressed first and funding will always be a factor.

Principal Park Planner McDaniel introduced Park Superintendent Emery to present on Ryan Bonaminio Park at the Tequesquite Arroyo. Park Superintendent Emery confirmed that all elements of the park came into play after two years of community meetings and the Environmental Impact Report (EIR) findings.

Chairperson Whatley commented she understands the Parks Master Plan process, yet is wondering if there are some improvements that can be done to Ryan Bonaminio Park in the meantime. Park Superintendent Emery confirmed that additional trash receptacles, doggy bags, and signage can be done soon and without the Master Plan process.
