VAN BUREN LAND AND INVESTMENT, INC. - DEVELOPMENT PROPOSAL - TWO-STORY OFFICE/RETAIL PROJECT - NORTHEASTERLY CORNER OF VAN BUREN BOULEVARD AND INDIANA AVENUE

Following discussion, motion was made by Councilmember Burnard and seconded by Vice Chair Davis (1) recommending that the City Council approve the development proposal by R.C. Hobbs Company, Inc., for the development of a retail and senior housing residential project located at 11124-11144 Pierce Street and 4870 La Sierra Avenue; and (2) directing staff to negotiate an agreement for the disposition of 2.4 acres Successor Agency owned property located at 11124-11144 Pierce Street and 4870 La Sierra Avenue, Five Points - Site B and subsequent development of a retail and senior housing residential project to be presented to the City Council for consideration. Motion carried unanimously.
