

## **MINUTES**

### **PUBLIC SAFETY COMMITTEE Wednesday, June 21, 2017, 1 p.m. Art Pick Council Chamber**

Chair Perry called the meeting to order at 1 p.m.

#### **REGULATION FOR PAWN SHOPS AND SECONDHAND DEALER ESTABLISHMENTS**

Following discussion, motion was made by Member Burnard and seconded by Chair Perry recommending that the City Council adopt an ordinance amending the Riverside Municipal Code to add Chapter 5.80 - Pawnshops and Secondhand Dealers to establish requirements related to pawn shops and secondhand dealer establishments. Motion carried unanimously.

#### **REVOCATION OF MESSAGE ESTABLISHMENT PERMIT - APPEAL - AA BODY MESSAGE - 4080 TYLER STREET, #A**

Following discussion, motion was made by Member Burnard and seconded by Chair Perry to deny the appeal of Fei Yang of AA Body Massage based on the evidence presented.

The denial is based on Section 5.52.050 of the Riverside Municipal Code and specifically, on the grounds that the holder of the establishment permit or certificate of registration is acting in a manner contrary to the provisions of this code.

Motion carried unanimously.

Chair Perry advised that pursuant to the vote, the Public Safety Committee is hereby denying the appeal of Fei Yang of AA Body Massage. The decision of the Public Safety Committee is final with no further right of appeal to the City Council. Because there is no provision for reconsideration of the decision, or for a written decision or written findings supporting the decision in any applicable provision of any statute, charter, or rule, this decision is final today. The appellant may seek judicial review of the decision pursuant to California Code of Civil Procedure, Section 1094.5 by filing a petition with the Riverside County Superior Court. The time within which judicial review must be sought is governed by Section 1094.6.


