The suggested revision to the Rules of Conduct Procedures Manual and pamphlet is a proposed addition to section 1(B-01). This addition will assist staff to take action when excluded individuals enter the building prior to the expiration of the exclusion notice.
- Item 11 Participation in the 2017 California State Library and the California Center for the Book Program – Book to Action**
The Library has again been selected and funded to participate in the annual Book to Action Program. Last year's book selection and guest speaker was Dr. Robert Putnam author of *Our Kids: The American Dream in Crisis*. This year's selection is *March* Books 1, 2 and 3 written by Congressman John Lewis. Book 3 is the 2016 winner of the Coretta Scott King award and the 2016 winner of the National Book Award for Young People's Literature, the first graphic novel ever to receive this distinction.

Nate Powell, the graphic artist for the *March* novels, will be this year's guest speaker. Director Kennon will update Trustees when a date is confirmed.

On a date soon to be announced, community members will be able to pick up a copy of the books for free, while supplies last at any Riverside Public Library location.

Book to Action is a program of the California Center for the Book, under the auspices of the California Library Association, and is supported by the U.S. Institute of Museum and Library Services under the provisions of the Library Services and Technology Act, administered in California by the State Librarian.
