

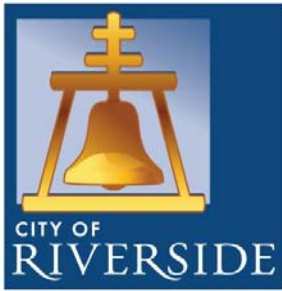

<b>PLANNING/ZONING MATTERS FROM THE AUDIENCE</b> There were no oral comments at this time.										
<b><u>PUBLIC HEARINGS</u></b>										
<b><u>PLANNING CASE P17-0073</u></b> – <i>Conditional Use Permit for an Indoor Playground Facility – 4860 La Sierra Ave (Ward 7)</i> Proposal by Ryan Condron of Luv2Play Riverside to consider a Conditional Use Permit to establish an indoor playground commercial complex. Matthew Taylor, Assistant Planner, presented the staff report. Ryan Condron, applicant, stated they were in agreement with the conditions. There were no comments from the audience. Following discussion the Planning Commission: 1) Determined that Planning Case P17-0073 constitutes an Existing Facility and is categorically exempt from the provisions of the California environmental Quality Act (CEQA) per Section 15301 of the CEQA Guidelines; and 2) Approved Planning Case P17-0073 based on the findings outlined in the staff report and subject to the recommended conditions. <b><u>PLANNING CASE P16-0854</u></b> – <i>Downtown Specific Plan Amendment</i> Proposal by the City of Riverside to amend the Downtown Specific Plan with regard to permitted and conditionally permitted land uses within the Raincross and Justice Center Districts. Luke Seibert, Associate Planner, presented the staff report. Jay Eastman, Principal Planner, announced that a comment had been received for this case and was distributed to the Commission prior to the meeting. He responded to the comments and explained the inconsistencies staff had identified. There were no comments from the audience. Following discussion the Planning Commission recommended that the City Council: 1) Determine that the proposed project is exempt from further California Environmental Quality Act review pursuant to Section 15061(b)(3), as it can be seen with certainty there is no possibility this proposed amendment to the Downtown Specific Plan will have a significant effect on the environment; 2) Approve Planning Case P16-0854 (Specific Plan Amendment), based on the justifications outlined in the staff report; and based on the findings	Motion Second Ayes	X	X	X	X	X	X	X	X
