PUBLIC SAFETY COMMITTEE Wednesday, July 19, 2017, 1 p.m. Art Pick Council Chamber

Chair Perry called the meeting to order at 1:03 p.m.

REVOCATION OF MESSAGE ESTABLISHMENT PERMIT - APPEAL - LA ASIAN SPA - 6863 BROCKTON AVENUE, #A

Following discussion, motion was made by Vice Chair Melendrez and seconded by Chair Perry to deny the appeal of Chune Fu of LA Asian Spa based on the evidence presented.

The denial is based on Section 5.52.130 of the Riverside Municipal Code and specifically, on the grounds that the holder of the establishment permit or certificate of registration is acting in a manner (a) contrary to the provisions of this code; (b) that constitutes a public nuisance; and (c) that is detrimental to the health, safety or welfare of the city or its inhabitants.

Motion carried unanimously.

Chair Perry advised that pursuant to the vote, the Public Safety Committee is hereby denying the appeal of Chune Fu, owner of LA Asian Spa. The decision of the Public Safety Committee is final with no further right of appeal to the City Council. Because there is no provision for reconsideration of the decision, or for a written decision or written findings supporting the decision in any applicable provision of any statute, charter, or rule, this decision is final today. The appellant may seek judicial review of the decision pursuant to California Code of Civil Procedure, Section 1094.5 by filing a petition with the Riverside County Superior Court. The time within which judicial review must be sought is governed by Section 1094.6.

REVOCATION OF MESSAGE ESTABLISHMENT PERMIT - APPEAL - MAGNOLIA RELAXING SPA - 7130 MAGNOLIA AVENUE, #M

Following discussion and without formal motion, the Committee unanimously approved a settlement agreement with the appellant as follows: Ms. Ji Gan agrees (1) to submit on the denial of her application for a massage permit and admits it has been denied; (2) to a 60-day suspension to not operate a massage establishment within the City of Riverside with the suspension to begin July 19, 2017; (3) that she may re-apply for a massage establishment permit within the 60 day period stated previously and if there are no other code violations or Penal Code violations within the 60 day period, the City will grant

Ms. Gan's re-submitted application for a massage establishment permit; and (4) to be fined \$1,000, which includes the City's fees and costs with payment shall be made to the City of Riverside.


