The Board of Public Utilities approved a Professional Consultant Services Agreement with Stephen Blum dba Tellus Venture Associates of Pacifica, California, for \$175,000 for implementation of phases 1 and 2 of Magellan's Fiber Business Model.

4 SEVENTEENTH AMENDMENT TO AGREEMENT FOR USE OF LOW INCOME UTILITY BILL AND DEPOSIT ASSISTANCE FUNDS WITH THE COMMUNITY ACTION PARTNERSHIP OF RIVERSIDE COUNTY, ANNUAL RENEWAL OF THE SHARING HOUSEHOLDS ASSIST RIVERSIDE'S ENERGY PROGRAM AGREEMENT— IN THE AMOUNT OF \$1,000,000

Board Member Kevin Foust requested this item be placed on the Discussion Calendar to discuss the program in more detail and concerned that RPU might be underserving the community. Assistant General Manager Mike Bacich said that this program is serving the community adequately and that there is new leadership of the Community Action Partnership (CAP) of Riverside County.

The Board requested that staff periodically bring updates back to the Board on the SHARE program and possibly having a representative from CAP give a report to the Board in the future.

Also the Board directed staff to review the online application for the SHARE program and be sure to remove any questions related to "naturalization", "proof of citizenship", etc. from the application.

Following discussion, the Board of Public Utilities recommended that the City Council:

- Approve the Seventeenth Amendment to the Agreement for use of Low-Income Utility Bill and Deposit Assistance Funds with the Community Action Partnership of Riverside County to extend the Sharing Households Assist Riverside's Energy program from July 1, 2017, through June 30, 2018, in the amount of \$1,000,000;
- 2. Authorize the City Manager, or his designee, to approve change orders up to a maximum of 10%, or \$100,000;

- 3. Direct Staff to seek approval by Board of Public Utilities and City Council for change orders over 10%, not to exceed 25%, or \$250,000; and
- 4. Authorize the City Manager, or his designee, to execute the Seventeenth Amendment to the Agreement for use of Low-Income Utility Bill and Deposit Assistance Funds with the Community Action Partnership of Riverside County, including making non-substantive changes.

- Awarded Bid No. RPU-7461 to Osmose Utilities Services, Inc. of Peachtree City, Georgia, for a term of three years, in the amount of \$2,537,640 for the General Order 165 Overhead Electric Distribution Inspection Program; and
- 3. Approved Work Order No. 1722605 in the amount of \$2,844,000.
