Commission Meeting Absences

A) May 24 Regular Meeting – Commissioner Jackson

Chair Adams advised that Commissioner Jackson was absent due to family illness. Commissioner Ortiz made a motion to excuse Commissioner Jackson's May 24th Regular Meeting absence; this was seconded by Commissioner Ybarra. Six Commissioners excused the absence; Commissioner Jackson abstained.

Julieann Hawk asked how the Commission would be addressing complaints RPD has determined to be "frivolous".

Chair Adams said that the issue with frivolous and other complaints that RPD had erroneously not sent to CPRC had been addressed. She said that RPD was currently working to rectify that situation.

A) 2017 Outreach Committee

Chair Adams reviewed the Outreach Committee's discussion topics in Vice-Chair Smith's absence. The CPRC Outreach presentation and PowerPoint video is up-to-date; waiting for discussion with ACM Nguyen and Marketing regarding the CPRC Facebook page; the RPU bill insert is complete and it has been recommended that it be given to Councilmembers for use in their newsletters; Eastside Reconciliation Coalition has a new website – www.EastsideReconciliation.org; work toward a second mental health forum has been postponed until fall per RPD's request; the infomercial script has been received and will be reviewed at the next Committee meeting; informed Commission of suggestion that Commissioners not currently serving on a committee take brochures to three community centers; letters and e-mails will be sent to community groups asking for interest in a CPRC presentation; Commissioner Evans obtained ad pricing for the Chamber of Commerce newsletter after staff suggested advertising in it.

- **A)** Mr. Hauptmann advised of the meeting with Django Sibley of the Los Angeles Police Commission's Office of Inspector General. Mr. Hauptmann said that he, Chair Adams, and Vice-Chair Smith would review their notes and create a presentation for the Commission regarding what was learned about L.A.'s use of "Totality of Circumstances" when reviewing officer-involved death (OID) cases.

Commissioner Jackson asked if the Commission would have a choice about whether or not to use this method when reviewing OIDs. Mr. Hauptmann said it would be the Commission's choice.

Commissioner Ortiz asked if NACOLE had commented on the use of "Totality of Circumstances" when reviewing OIDs. Mr. Hauptmann said he had seen nothing about that from NACOLE.

Commissioner Ybarra asked if Hayes v. San Diego was being reviewed by a higher court and expressed concern that civilian oversight is getting too involved in incident tactics. Mr. Hauptmann said Los Angeles isn't trying to dictate tactics, but looks at deviation from training and the extent of that deviation.

Mr. Hauptmann also advised that Mr. Sibley had said he would make a public presentation to the Commission.

- **B)** Chair Adams said that high school outreach would be discussed at the next Outreach Committee meeting.
- **C)** Chair Adams noted that putting brochure holders in community centers had been discussed earlier in the meeting.
- **D)** Chair Adams noted that Commissioner Jackson was working on the RPD survey. Commissioner Jackson said she hoped to have something ready in time for the next Outreach Committee meeting.
- E) Chair Adams advised that progress was being made on the receipt of survey forms.

Annual Review of the City's Code of Ethics and Conduct
