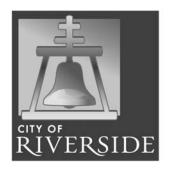

SPEED LIMIT ZONE - COLLETT/DIANA/MULBERRY/UNIVERSITY -ORDINANCE ADOPTED
