

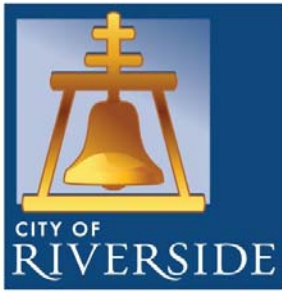

<u>PLANNING CASES P18-0008 and P18-0009 – General Plan Amendment and Rezoning – 0.23 acre vacant parcel, west side of Van Buren Boulevard, approximately 950 feet north of Lincoln Avenue – Ward 5</u>										
Proposal by the City of Riverside to consider the following entitlements: 1) a General Plan Amendment to amend the land use designation from MDR – Medium Density Residential to VHDR – Very High Density Residential; and 2) a Zoning Code Amendment to change the zone the R-1-7000 Single-Family Residential Zone to R-4 Multiple Family Residential Zone. Judy Egüez, Associate Planner, presented the staff report. There were no comments from the audience. Following discussion the Planning Commission recommended that the City Council:										
1) Determine that the proposed project is consistent with the Final EIR for the 2014-2021 Housing Element Update/Housing Implementation Plan certified in December 2017 (SCH No. 2017041039) subject to the compliance with the Mitigation Monitoring and Reporting Program approved therefor; and 2) Approve Planning Cases P18-0008 (General Plan Amendment) and P18-0009 (Rezone) based on the findings outlined in the staff report and subject to the recommended conditions.
