DEVELOPMENT OF HOUSING AUTHORITY-OWNED PROPERTY- 11502 ANACAPA PLACE

Following discussion, a motion was made by Member Mac Arthur and seconded by Vice Chair Perry recommending that the City Council and Housing Authority Board approve a development proposal from Northtown Housing, Inc. for HOME Investment Partnerships Program Loan in the amount of \$354,736 for acquisition and construction of two single-family homes on Housing Authority owned property located at 11502 Anacapa Place and Assessor's Parcel Number 141-173-0136. Motion carried unanimously.

DEVELOPMENT OF THE SHOWCASE AT THE FOX ENTERTAINMENT PLAZA

Following discussion, a motion was made by Councilmember Melendrez and seconded by Vice Chair Perry (1) selecting Bailey California Properties, LLC proposal for preservation and adaptive reuse of the City-owned Farm House Motel; and (2) directing staff to negotiate a Purchase, Sale, and Development Agreement with Bailey California Properties, LLC for the disposition of the .97 acre City-owned Farm House Motel, located at 1393 University Avenue, Assessor's Parcel Number 250-190-009, to facilitate the development of a retail project to be presented to the City Council for consideration . Motion carried unanimously.
