4. UPDATE ON PROTECTION OF THE PARENT NAVEL ORANGE TREE FROM THE ASIAN CITRUS PSYLLID AND HUANGLONGBING CITRUS GREENING DISEASE

Director Cruz invited Park Superintendent Emery to present.

Park Superintendent Emery presented the report and explained the importance and significance of the Parent Navel Tree to the City, State and Nationally.

Commissioner Whatley entered the meeting at this time (6:37 p.m.).

Commissioner Negron entered the meeting at this time (6:38 p.m.).

Commissioner Elliot asked who maintains the tree and Commissioner Humphreys asked when the last inspection took place.

Park Superintendent Emery confirmed that a contractor performs the pesticides and University of California Riverside Team does the trimming and inspection of diseases. The last inspection took place about three months ago.

Chair Rounds inquired about community outreach in regards to the disease at residential trees.

Economic Development Department representative, Joyce Jong, informed the Commission about the continuous community outreach her teams has completed.

Chair Rounds asked if there's a kit for residents whose trees have become endangered with the disease.

Dr. Georgios Vidalakis informed the Commission about the "trickiness" in regards to the disease. Technically all citrus trees are at risk in both public and private areas. He confirmed that if a tree is infected, state-law requires the tree be removed. Dr. Georgios Vidalakis spoke about the importance about protecting the Parent Navel Tree with the proposed fabric. He also mentioned that the tree has survived for 140+ years and it can last for another half century if it's protected.
