3. PUBLIC WORKS DEPARTMENT URBAN FORESTRY / LANDSCAPE DIVISION QUARTERLY ACTIVITY REPORT

Director Cruz shared that Robert Filiar, Urban Forester, was present to respond to any questions.

Commissioner Johnson expressed concern in regard to the amount of trees being removed is greater than the amount of trees being replaced, and inquired about a near-future environmental effect on the City.

Urban Forester Filiar confirmed the Department is researching and placing trees in the right places at the right time.

Commissioner Humphreys shared her concern about the proper life cycle for trimming specific species of trees.

Urban Forester Filiar confirmed the trimming cycle prior to Measure Z was 9 - 10 years; currently working on a 6 - 7 year cycle and trimming according to species' seasons when needed.

Chair Cardullo asked who residents should contact in regards to tree related issues.

Urban Forester Filiar confirmed the Riverside 311 is the correct way to report any tree related concerns; the response time is around 60 days with a phone call or door handle.
