Director Christmas reported the Main Library project went out for bid on October 9, 2018. The project is a traditional design-bid-build delivery procurement in which the lowest responsive bidder will be awarded the contract. The bids are due on November 13, 2018. A pre-bid meeting is scheduled for October 23, 2018. The timeline for the Cheech project and the Main Library project would not cause a need for the Main Library to relocate temporarily if there are no changes to the main library construction. Relocation funds were not identified for the Main Library Project. A special meeting may be scheduled depending on the timing of the approved contract with the lowest responsive bidder.
