

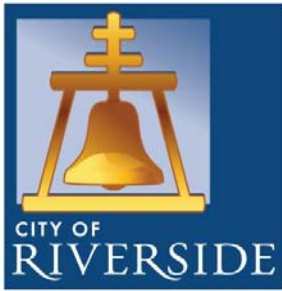

<u>PLANNING CASE P17-0533 – Tract Map 37146 – 1606 Orange Street, Ward 1</u>										
Proposal by BJ Ghuman of Go-Man Construction and Investments, Inc. to consider Tract Map 37146 to subdivide a 1.96-acre parcel, developed with a single-family residence and ancillary detached structures, into six(6) parcels for future development of single-family residences. Suhaim Bawany, Assistant Planner, presented the staff report. BJ Ghuman, applicant, stated they were in agreement with the recommended conditions. There were no comments from the audience. The public hearing was closed. Following discussion the Planning Commission recommended that the City Council: 1) Determined that the proposed project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Section 15332 (In-Fill Development Projects); and 2) Approved Planning Case P17-0533 (Tract Map) based on the findings outlined in the staff report and subject to the recommended conditions.
