



PLANNING CASE P18-0569 - Certificate of Appropriateness, Project Plans for the Construction of a six-story Student Housing Building, 8432 Magnolia Avenue, Ward 5

Certificate of Appropriateness requested by Steve Smith of California Baptist University, of project plans for the construction of a six-story student housing building, consisting of 182,555 square feet and 590 student beds within the eligible California Baptist University Historic District. Scott Watson, Associate Planner, presented the staff report. David Leonard, representing California Baptist University stated they were in agreement with the recommended conditions with the exception of condition 3. 
