TRAFFIC CONTROL ALTERNATIVES AT VICTORIA AVENUE/WASHINGTON STREET INTERSECTION

Following discussion, motion was made by Vice Chair Mac Arthur and seconded by Chair Soubirous to (1) receive and order filed the report on traffic control alternatives at the intersection of Victoria Avenue and Washington Street; (2) direct staff to conduct community outreach on other traffic control alternatives acknowledging that there is no community support for roundabouts; and (3) forward a discussion of alternative solutions to the City Council at a workshop within ninety days. Motion carried unanimously.

DEPLOYMENT OF SHARED ACTIVE TRANSPORTATION SERVICES AND PERMITTING/FEE PROGRAM UPDATE

Following discussion, motion was made by Member Melendrez and seconded by Vice Chair Mac Arthur to (1) receive and order filed the update on the deployment of shared active transportation services (i.e. scooters); (2) authorize staff to negotiate an Interim Operating Agreement with Bird Rides, Inc., and additional interested shared active transportation services; and (3) direct staff

prepare a permitting/fee program for City Council consideration in February 2019. Motion carried unanimously.
