PUBLIC HEARINGS										
PLANNING CASES P18-0646, P18-0648 and P18-0649 — Conditional Use Permit, Design Review, and Variance, Vehicle Fuel Station Replacement, 8283 Arlington Avenue, Ward 7 Proposal by Karl Huy, Travis Companies, Inc. to consider the following entitlements for the replacement of a vehicle fuel station: 1) a Conditional Use Permit to permit a vehicle fuel station (Chevron) including a fueling canopy with 8 gasoline pumps and a 2,230-square-foot convenience store; 2) Design Review of project plans; and 3) a Variance to allow a reduced rear yard building setback. Matthew Taylor, Associate Planner, presented the staff report. Karl Huy, Travis Companies, stated they were in agreement with the recommended conditions. There were no comments from the audience. The Public Hearing was closed. Following discussion the Planning Commission: 1) Determined that the proposed project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the CEQA Guidelines, as the proposed project will not have a significant effect on the environment; 2) Approved Planning Cases P18-0646 (Conditional Use Permit), P18-0648 (Design Review), and P18-0649 (Variance), based on the findings outlined in the Staff Report and subject to the recommended conditions.
