
Chair Hemenway convened the meeting at 1 p.m.

## REVIEW OF CITY-OWNED PROPERTIES FOR DECLARATION AS SURPLUS TO GENERATE SALE REVENUE

Following discussion, it was moved by Member Fierro and seconded by Vice-Chair Plascencia to (1) forward the list of City-owned properties to the Budget Engagement Commission to determine which specific properties, if any, should be recommended to City Council to declare as surplus for staff to sell as a possible solution to either generate sale revenue or reduce operating costs to address structural deficits like the CalPERS Challenge and financial impacts associated with COVID-19; and (2) return to the Financial Performance and Budget Committee with a list of properties recommended by the Budget Engagement Commission for City Council consideration to approve and authorize staff to market for sale in accordance with the City's Administrative Manual Section 8.003.00 - Disposition and Sale of City Owned Real Property. The motion carried unanimously.

# CASE PSP20-0007 - OFF-SITE ADVERTISING ON CITY-OWNED SITES ALONG FREEWAYS AND ARTERIAL RIGHTS-OF-WAY

Following discussion and review of options for off-site advertising on City-owned sites along freeways and off-site advertising/gateways along City arterial rights-of-way as possible solutions to generate revenue to address the CalPERS Challenge and financial impacts associated with COVID-19, it was moved by Member Fierro and seconded by Vice-Chair Plascencia to direct staff to develop a draft scope of Request for Proposals and outline process and potential costs for off-site advertising on City-owned sites along freeways and off-site advertising/gateways along arterial rights-of-way for City Council consideration. The motion carried unanimously.
