RIVERSIDE TRANSIT AGENCY VINE STREET MOBILITY HUB

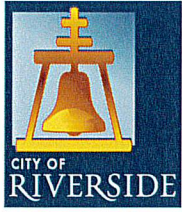
Following discussion, it was moved by Vice Chair Perry and seconded by Member Hemenway to receive and order filed the update from the Riverside Transit Agency regarding the planned Vine Street Mobility Hub. The motion carried unanimously.

REMOVAL OF SPEED HUMPS FROM NEIGHBORHOOD TRAFFIC MANAGEMENT PROGRAM

Following discussion, it was moved by Vice Chair Perry and seconded by Member Hemenway recommending the City Council approve the removal of speed humps from the Neighborhood Traffic Management Program. Motion carried with Chair Conder voting no.

REQUIREMENTS, POLICIES AND FEES FOR REQUESTS TO TEMPORARILY CEASE PARKING ENFORCEMENT FOR CLASS II BIKE LANES

Following discussion, it was moved by Member Hemenway and seconded by Vice Chair Perry to recommend that the City Council (1) establish the requirements and procedures for individuals, businesses, agencies, and/or entities including various City Departments requesting to temporarily cease parking enforcement within restricted Class II Bike Lanes during various events; (2) waive the standard \$369.36 Lane Closure Permit fee and any insurance requirements for permits issued for this purpose; (3) waive any fees related to inspection services that may be required at a rate of \$118 per hour plus 14 percent

surcharge; (4) establish a schedule of fees and charges associated with City Streets Division staff performance of services related to the deployment and removal of required state approved "Share the Road" and Bike Lane closure signs and other traffic control devices for public requests involving temporary cease of parking enforcement and closure of Class II Bike Lanes; (5) revise the Public Works Department section of the City's Schedule of Fees and Charges to include the new fees outlined in this report; and (6) adopt an ordinance to revise Section 3.30.030 of the Riverside Municipal Code to provide for adjustments to the City's fees and charges for Public Works to add the newly proposed fees. The motion carried unanimously.

There were no oral comments given at this time.

ITEMS FOR FUTURE COMMITTEE CONSIDERATION

Vice Chair Perry requested staff evaluate the need and necessity for a half traffic signal light from eastbound Magnolia Avenue into Northgate González Market at 10391 Magnolia Avenue to include responsibility of fiscal and engineering costs and report back to the City Council Mobility and Infrastructure Committee in September or October.
