### **DISCUSSION CALENDAR**

### DIRECTOR OF EMERGENCY SERVICES MINIMUM STAFFING ORDER

Following discussion, it was moved by Councilmember Edwards and seconded by Councilmember Fierro to (1) receive and order filed the review of the Order of the Director of Emergency Services to provide for minimum staffing in order to slow down the spread of COVID-19 among City staff; (2) continue Minimum Staffing order; and (3) return to City Council in thirty days with a further review of minimum staffing.

Following further discussion, a substitute motion was made by Councilwoman Plascencia and seconded by Councilmember Perry to extend the Minimum Staffing Order to July 7, 2020, with an update on every City Council agenda including the County of Riverside employee return to work progress. The motion carried unanimously.

### PROTECTION FOR GROCERY, PHARMACY, AND OTHER RETAIL WORKERS

Following discussion, it was moved by Councilmember Fierro and seconded by Councilwoman Plascencia to (1) receive and order filed an update on existing protections for grocery and pharmacy retail workers under Resolution No. 23569 adopted on April 21 2020; and (2) continue these protections to the grocery and pharmacy establishments within the City limits and return in sixty days for further review. The motion carried unanimously.

AGREEMENT - FORENSIC REVIEW - SOUTHERN CALIFORNIA PUBLIC POWER AUTHORITY Following discussion, it was moved by Councilmember Hemenway and seconded by Councilmember Fierro to (1) approve the Professional Consultant Services Agreement from RFP 1963 for forensic review of the City of Riverside participation in the Southern California Public Power Authority with Eide Bailly, LLP, in an amount not-to-exceed \$115,500 and a term ending December 31, 2020; (2) fully fund the contract from Public Utilities Administration Professional Services Account; and (3) authorize the City Manager, or designee, to execute all documents pursuant to the Professional Consultant Services

BUSINESS POSTING OF STATEWIDE MASK ORDER - CHECKLIST OF SAFETY AND PROTECTIVE MEASURES

Following discussion, it was moved by Councilmember Fierro and seconded by Councilmember Edwards to (1) require opened businesses to post notice of the statewide mask order and a checklist with safety and protective measures they have implemented in a easily-accessible place in their establishment; (2) direct staff to conduct comprehensive and sustained outreach to businesses and residents regarding the statewide mask order and the subsequent public health need for all residents to wear face masks while in public to curb the spread of COVID-19 and continue to reopen our economy by (a) contacting a targeted list of customer-facing businesses about the new mask mandate and the required notice, coordinating with the Greater Riverside Chambers of Commerce, the Greater Riverside Hispanic Chamber of Commerce, the Riverside Arlington Business Partnership, the Riverside County Black Chamber of Commerce, the Riverside Downtown Partnership, and other community business groups; and (b) conducting a social media campaign explaining the public health reasons to wear a mask to curb the spread of COVID-19 and protect our community and economy; (3) review current City messaging and communications on COVID-19 and discussing other possible methods to encourage utilization of protective measures; and (4) return to the City Council with a comprehensive communication plan as soon as possible. The motion carried with Councilmembers Edwards, Melendrez, Fierro, and Hemenway, and Councilwoman Plascencia voting aye and Councilmembers Conder and Perry voting no.
