CALL TO ORDER

DISCUSSION AND ACTION CALENDAR

Item 9 CARES Act Update for Distance Learning

Library Director Christmas provided an update on funding from CARES Act for Distance Learning. The following was allocated to the Library: \$20,000 in free printing for students; \$21,474 to increase exterior Wifi; \$5,000 for Storytime kits for 800 families; \$40,000 for school supplies to assist 400 students; \$175,000 for 250 Ipads for community checkout and \$2,132 for access points at Arlanza for Learning Center Access.

Additional funding was recieved for the library to partner with the following organizations to support their distance learning efforts.

1. Riverside Unified School District - hotspots for students - \$208,300
2. Alvord Unified School District - hotspots for students - \$85,231.76
3. Osher Life Long Learning - 75 scholarships for seniors - \$10,875
4. Riverside Community College District — assist with marketing of educational classes for adult learning support - \$10,000
5. Big Brothers and Big Sisters - direct student support -\$188,662
6. California School for the Deaf, Riverside — early learning programs \$23,000

All CARES Act funds will be spent by December 31, 2020. The update was received and filed with no further action taken.

Item 10 Priority-Based Budgeting Fiscal Year 2021/22

Library Director Christmas provided an update on the priority-based budgeting for fiscal year 2021/22. Priority-based budgeting supports the decision-making process to assign resources to programs and services that align with the City's strategic plan and support the City's strategic goals and objectives. Priority-

based budgeting helps the decision-making process for the upcoming budget cycle within the constraints of the existing fiscal environment.

Priority-based budgeting is currently underway. Library Administrative and Neighborhoods staff are working on this to ensure all aspects of department functions are included. The implementation timeline allows for Program Inventory, Cost Allocations, Department Scoring (how programs support the community), Peer Review of cross functional teams, and Final Review where action is taken.

The update was received and filed with no action taken.

Item 11 New Main Library update

Library Director Christmas informed the Board of the progress of the New Main Library construction is 90% complete in early fourth quarter of 2020. Staff have scheduled tours with Electeds and Board of Library Trustees in small groups. The City will receive the keys to the building on December 7. Furniture has been brought in and staff will be moving in. The opening date has not been determined due to COVID-19. Library curbside service is still being offered at other locations.

The update was received and filed with no action taken.

Item 12 Specialist Jesus S. Duran Eastside Library update

Library Director Christmas provided an update on the SPC Jesus S. Duran Eastside Library. There was a typo in the report indicating the year 2021 for the Council to approve Professional Services Agreement for the top architectural firm, but the correct year is 2020.

The report was filed and received with no action taken.

Item 13 Transfer of local history materials relevant to various jurisdictions

The Riverside Public Library housed a substantial number of items in the Local History Resources Center between 1911 and 1997 when the Riverside City and Riverside County Libraries were joined as one system; the Riverside City and County Library. During this time many items that were not local to Riverside City, but rather had significance for Riverside County were collected. When the Riverside County Library left the Riverside City Library in 1997, many local history items continued to be housed by the Riverside City Library. A list of housed items is attached the report. The receiving jurisdictions have the ability and capacity to maintain their local history collections respectively.

Following discussion, the Board of Library Trustees unanimously voted to recommend that the City Council authorize the donation and transfer of the surplus of local history collection relevant to various jurisdictions.
