OFFICE OF HOMELESS SOLUTIONS FUTURE DATA DASHBOARD OVERVIEW

Following discussion and without formal motion, the Committee unanimously received and ordered filed an overview presentation on the Office of Homeless Solutions Data Dashboard; and (2) recommended that staff expand work with other cities, track specialized populations over time to have a better sense of what services to provide, use respectful terminology, include measurable goals, and implement a suggestion box. The motion carried unanimously.

ESTABLISH PUBLIC HOUSING AGENCY - SECTION 8 HOUSING CHOICE VOUCHERS

Following discussion, it was moved by Member Plascencia and seconded by Chair Edwards to direct staff to provide additional information on the process of establishing a City Public Housing Agency recognized by the U.S. Department of Housing and Urban Development to receive and administer Section 8 Housing Choice Voucher to the Housing and Homelessness Committee in January 2012. The motion carried with Member Plascencia and Chair Edwards voting age and Vice-Chair Melendrez voting no.

HOUSING AUTHORITY AFFORDABLE HOUSING PROJECTS UPDATE

Following discussion and without formal motion, the Committee unanimously received and ordered filed an update on Housing Authority affordable housing projects.

INCLUSIONARY HOUSING PROGRAMS OVERVIEW.

Following discussion, it was moved by Vice-Chair Melendrez and seconded by Chair Edwards to forward appointment of a consultant to the City Council to perform an Inclusionary Housing Program feasibility study.
