### <u>PUBLIC PARKING FUND - PARKING ECOSYSTEM SUSTAINABILITY PLAN PART 1 AND INFRASTRUCTURE AND EQUIPMENT NEEDS</u>

Following discussion, it was moved by Vice Chair Edwards and seconded by Chair Plascencia to (1) receive and order filed the Public Parking Fund update; (2) recommend that City Council approve to replace the 157 single-space meters with approximately 22 multi-space pay stations and signs; and (3) direct staff to bring back to the Land Use, Sustainability and Resilience Committee Parking Ecosystem Sustainability Plan Part 2 early next year, after the Finance Committee receives the report on surplus properties. The motion carried unanimously.

## RESUME USE OF PRODUCTS CONTAINING GLYPHOSATE FOR WEED CONTROL ON CITY MAINTAINED PROPERTIES AND FACILITIES

Following discussion, it was moved by Vice Chair Edwards and seconded by Chair Plascencia to recommend to the City Council that staff be able to resume the use of glyphosate products for weed control on City-maintained properties and facilities. The motion carried unanimously.
