Following further discussion, it was moved by Councilmember Perry and seconded by Councilmember Conder to defer consideration of sanctions until the findings and decision of violation of RMC Section 2.78.060(M) regarding violation of the Sunshine Ordinance returns to the City Council for consideration. The motion carried unanimously.

Councilwoman Plascencia rejoined the meeting at this time.

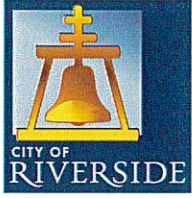
CITY ATTORNEY REPORT ON CLOSED SESSIONS
