UTILITY AGREEMENT 24533 - STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION - WASHINGTON STREET OVERCROSSING ON INTERSTATE 215 PROJECT

The Board of Public Utilities recommended that the City Council (1) approve the Utility Agreement 24533 between State of California Department of Transportation and City of Riverside for reimbursement to City of Riverside in the amount of \$37,483.33 for Washington Street Overcrossing on Interstate 215 Project construction related to utility conflict mitigation; (2) authorize the City Manager, or his designee, to execute the Utility Agreement and any amendments including those to increase the reimbursable amount of the agreement; (3) authorize a supplemental appropriation in the amount of \$37,483.33 from the Water Fund (520 Undesignated Reserve Fund) to a capital project account as established by the Finance Department to fund the project; and (4) authorize an increase in estimated revenue of \$37,483.33 to reflect the reimbursement to the Water Fund.

### GREENHOUSE GAS ALLOWANCE USE VALUE AND PROCEEDS UPDATE


