3. Interim City Attorney Kristi Smith presented on the Brown Act and Sunshine ordinance. Followed by an in-depth Commissioner question and answer period on topics regarding social media, standing rules, scope of the Commission and the opinion of the City Attorney's Office that the Item 7 discussion is not within the scope and purview of the



Commission. The Commission disagreed with the City Attorney's advice and proceeded later in the meeting with Item 7.

- 5. Commission discussed the death of Leroy A. Stephenson following one (1) written public comment letter from Ms. Amy Conger. Previously in the meeting, Interim City Attorney Smith advised that topics such as officer-involved deaths are not under the purview of the Human Relations Commission, rather the sole responsibility of the Community Police Review Commission. Ms. Amy Conger also attended and spoke at the meeting, per the request of the HRC in December 2020 to further explain her submitted letter and questions she had submitted in said letter. No formal action was taken by the Commission following a brief question and answer with Ms. Conger.

COMMUNICATIONS:

6. Staff Update:

A representative from City Attorney's Office, Lauren Sanchez, will attend future meetings to assist the Commission with questions needing counsel. The March meeting will see the election of a new Chair, Vice-Chair, and Parliamentarian. We thank outgoing Commissioners McNulty and Mabon for their years of service.

Commissioner Ayra requested a presentation from Hope Palacio on her policing policy. Commissioner Ayra also requested that the Commission receive an update from staff on where the health recommendation for the Community Health Needs Assessment stands to date. Commissioner Rooths requested that the Commission receive an update from staff on where the Trauma Sensitivity Training recommendation stands to date. Commissioner Davis requested that an item be created for the formation of an ad hoc committee to explore ways for act upon Agenda Item 7 moving forward.
