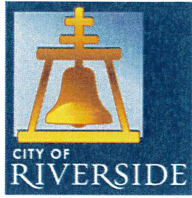

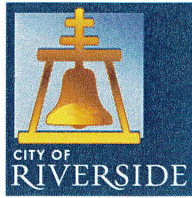
### LANGUAGE ACCESS AND TRANSLATION SERVICES UPDATE
