2. Presentation from Path of Life Ministries about the Homeless Housing Opportunities they provide as well as the services provided to help people move toward self-sufficiency.


Leonard Jarman is the Chief Solutions Officer for Path of Life Ministries (POLM) and has been with them since 2005. The Mission of the POLM is rescue, restore, and rebuild. POLM uses a holistic, community-based approach to improve the health and vitality of those affected by

homelessness. POLM promises that whoever reaches out to them will receive help to get out of that crisis, stably housed, and moving toward self-sufficiency. Leonard Jarman explains that homelessness is a public health and humanitarian crisis and it a multi-faceted problem that demands multifaceted solutions. POLM offers services such as shelters, permanent housing, street outreach, rapid re-housing, and employment assistance. They also implement evidence-based interventions and best practices that effectively help individuals and families end their homelessness crisis. They meet people where they are and encourage positive change in their lives and the shelters are low barrier. The goal is to connect individuals and families experiencing homelessness quickly and successfully to permanent housing without preconditions and barriers, and when they are housed, support services are offered in their home to help maintain the housing. POLM explores creative, flexible, safe, and cost-effective solutions to quickly resolve a housing crisis, even if it is just temporarily. POLM maintains and operates the following facilities: Community Shelter, Family Shelter, and Cold Weather Shelter. They also have the following services and programs available: Riverside and Jurupa Valley Outreach/Homelessness Prevention, Landlord Locator Service, Employment Pipeline Program, and Mobile Behavioral Health.

DISCUSSION AND ACTION CALENDAR

3. Approve minutes for the meeting of March 18, 2021

Motion to approve – Commissioner Lewis Second – Commissioner Aleman Vice Chair Lopez did not respond during the roll call vote All in favor

4. Consideration of the annual election of officers.

Staff member Jessica Spiking explained that elections are supposed to be done in March of every year however due to COVID-19, elections for the term starting in March of 2020 occurred in November of 2020. The election taking place during this meeting is for the term starting in March of 2021. Staff member Shari Call verified that officers serve a term of one year and they may serve no more than two successive years in the same office.

Commissioner Lewis nominated Commissioner Perkins for Chair Second – Commissioner Davis Commissioner Lewis nominated Commissioner Nelson for Vice Chair Second – Commissioner Davis

Commissioner Lewis motioned to close nominations Second – Commissioner Nelson

Vice Chair Lopez did not respond during the roll call vote

Commissioner Ontko requested confirmation that the nominees officially accepted the positions and both Commissioner Perkins and Commissioner Nelson confirmed they accepted the positions in Office.

COMMUNICATIONS

9. Update on Brochures

Commissioner Nelson stated that he has not been able to make any changes/updates on the existing brochure but will send them over to Staff Member Jessica Spiking so they can be discussed during the next meeting.

10. Update on Public Outreach to publicize the Commission

Staff member Jessica Spiking informed the Commissioners that she spoke with the City of Riverside's TV crew and they explained that they are able to see how many people are viewing the meetings after they have taken place and it is only the people who are viewing the meeting through the website and the via a TV channel. She has requested those numbers from the previous meetings and is waiting for that information.

Commissioner Lewis had asked if the meetings could be publicized on the City website or some other form of media. She wants people to know when the Commission on Disabilities meetings are so that the Commission can receive feedback and can engage with the community.

11. Update on ways to receive feedback form the Community about any needs or concerns they may have.

Commissioner Aleman inquired about what they can do as Commissioners when it comes to advertising the meetings and how can we get the word out and engage with the Community. Staff member Jessica Spiking suggested creating a flyer with meeting information that can be posted on approved websites. Commissioner Aleman asked if we could post this information on sites such as the City of Riverside's Facebook page as well as the group called "What's going on in Riverside County?" Commissioner Aleman volunteered to create a draft flyer. Commissioner Perkins requested that staff member Jessica Spiking reach out to other Commissions within the City of Riverside to see how they are getting the word out there.

Commissioner Lewis stated that she would like to look at things statistically to see where there is a greater need for assistance in the disabled community. Once the Commission is given feedback, they will bring in presenters from various groups that will inform the community about assistance and programs that they provide. She also stated that the Commission should set up goals that they would like to accomplish throughout the year. Commissioner Lewis requested a presentation from the Disability Resource Center at Riverside City College.

Commissioner Krick made a comment that he was able to navigate the website and view the live Commission on Disabilities meeting. Commissioner Aleman agreed that the City website page is good however she wants to hear more from the community regarding how the

Commission can help with concerns or challenges people have within the City. Commissioner Lewis mentioned that a survey might be a good method to get an idea of what main concerns the community have.

Commissioner Krick had an idea that the Commission on Disabilities website should have a list of all the guest speakers that have presented at the meetings with a link for that presentation. Commissioner Ontko stated that the Department of Vocational Rehabilitation has a team of individuals called Community Resource Network Individuals and they have put together an extensive list of resources. The manager for the business engagement team is Christopher Fernandez and Commissioner Ontko recommended that the Commission partners with them to possibly get the link to the resource network posted on the City's website. Commissioner Ontko strongly suggests that the Commission partner with the Department of Rehabilitation to utilize their existing resources.

12. Updates on conferences, seminars, and regional meetings attended by Commissioners.

Commissioner Lewis stated that she has been attending monthly meetings with Riverside County Mental Health. They have a group that meets on the third Wednesday of every month from 10AM-11:30AM and they discuss different events and workshops that are available for the Community. Commissioner Lewis stated now that churches are opening back up, she is looking forward to engaging ministers because sometimes they are the first responders for people who need help. She also mentioned that in Orange Crest, there is an office that helps Veterans and she is going to go talk with them to see if they would be interested in presenting at one of the meetings. Commissioner Krick mentioned that the Transportation Service provided by the City of Riverside for the elderly and disabled community has rebranded their name to Riverside Connect. Chair Alexander mentioned that he shared this transportation resource on the Nextdoor Website and there was a person from his community that needed this information and was able to use this resource. Chair Alexander stated that he partakes in the California Hands and Voices meetings and he will be attending one in the near future.

13. Items for future consideration as requested by Commission Members

Commissioner Lewis suggested a presentation from Disability Resource Center at Riverside City College.

Commissioner Ontko recommended the Commission reach out to the Department of Vocational Rehabilitation which has a team of individuals called Community Resource Network Individuals and they have a wide range of resources available.
