Following discussion, it was moved by Member Cervantes and seconded by Vice Chair Plascencia to (1) receive and order filed an update on the feasibility and economic impacts of an Inclusionary Housing Program for the City of Riverside; (2) direct staff to proceed with the Inclusionary Housing Program; and (3) request staff to return to the Housing and Homelessness Committee in January 2022 with an update on the program. The motion carried unanimously.

### "WHO TO CALL" HOMELESS GUIDE FOR BUSINESSES AND RESIDENTS

Following discussion, it was moved by Chair Edwards and seconded by Vice Chair Plascencia to (1) direct the Office of Homeless Solutions staff to work with the Office of Communications to develop a "Who to Call" homeless guide for businesses and residents; and (2) create a flyer with costs and work with the Public Safety Engagement Team to streamline the process on additional resources for businesses and residents for assistance with homeless individuals; and (4) return to the Committee with an updated guide at the next Housing and Homelessness Committee meeting. The motion carried unanimously.
