
There was no one wishing to address the Committee.

### SMOKE-FREE MULTI-UNIT HOUSING POLICIES - PROPOSED ORDINANCE

Following discussion, it was moved by Chair Perry and seconded by Member Plascencia to (1) receive and order filed a report on smoke-free multi-unit housing policies; and (2) direct staff to prepare a revised ordinance regarding desired regulatory requirements for developing a smoke-free multi-unit housing policy in the City of Riverside and return to the Committee in December. The motion carried unanimously.

### GAGE CANAL TRAIL IMPROVEMENT PROJECT UPDATE

Following discussion, it was moved by Member Plascencia and seconded by Vice Chair Conder to (1) receive and order filed an update on the Gage Canal Trail Improvements Project; (2) recommend that the City Council approve the execution of an interdepartmental Memorandum of Understanding between the City of Riverside Public Utilities Department, Water Division (RPU), and the Parks, Recreation and Community Services Department (PRCSD); and (3) include an update on the discussion with the Gage Canal Board in the City Council staff report and, if there is an issue with the Gage Canal Board, the item be brought back to Committee for further discussion. The motion carried unanimously.
