PUBLIC HEARINGS

PLANNING CASES – DP-2021-00523 (CONDITIONAL USE PERMIT) and DP-2021-00522 (DESIGN REVIEW) – 7200 ARLINGTON AVENUE, WARD 6

Proposal by Todd Huber on behalf of CCF PCG Riverside Plaza, LLC, to consider the following entitlements to facilitate the construction of a vehicle wash facility: 1) Conditional Use Permit to permit a self-automated vehicle wash facility; and 2) Design Review of project plans. Jessica Newton, Associate Planner, presented the staff report. After publication of report staff received a letter in support which has been distributed to the Commission. Todd Huber, applicant, stated they were in agreement with the recommended conditions. Public Comment: Cindy Roth spoke in support of the project. An individual requested clarification regarding traffic impacts. The public hearing was closed. Following discussion it was moved by Commissioner Villalobos and seconded by Commissioner Ridgway to: 1) Determine that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15332 (In-Fill Development Projects) of the CEQA Guidelines, as the project will not have a significant effect on the 2) Approve Planning Cases DP-2021-00523 (Conditional Use Permit) environment; and and DP-2021-00522 (Design Review), based on the findings outlined in the staff report and subject to the recommended conditions.

Chair Kirby advised of the appeal period.
