### SANTA ANA RIVER BOTTOM ENCAMPMENT RESPONSE PLAN

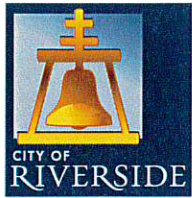
Following discussion and without formal motion, the Committee received and ordered filed an update on Santa Ana River Bottom Encampment Response Plan.
