Following discussion, it was moved by Member Avery and seconded by Vice Chair Rodriguez to approve the minutes of October 20, 2021, as presented. The motion carried with Chair Benavidez, Vice Chair Rodriguez and Members Avery, Burns, Mabon, Newberry, Norsell, and Ramirez voting aye and Members Clymer, Goldman, and McKeith absent.

DISCUSSION CALENDAR

REVIEW OF FINAL DRAFT REPORT TO CITY COUNCIL REGARDING MAYORAL AUTHORITY

Following discussion, it was moved by Member Avery and seconded by Vice Chair Rodriguez to recommend to the City Council an amendment to the City Charter to include within the Mayor's veto power the power to veto all formal actions taken by the City Council, except an ordinance proposed by initiative petition and including but not limited to any emergency ordinance, the annual budget and any formal action taken to appoint, adjust compensation, suspend or remove any officer or employee appointed by the City Council and place the proposed ballot question on a ballot for voter approval for such veto authority:

Proposed Ballot question: *Shall the measure amending the City of Riverside's Charter to amend the Mayor's power to include the power to veto, within five days, any formal action taken by the City Council, including but not limited to any emergency ordinance, the annual budget, and any formal action taken to appoint, adjust compensation, suspend or remove any officer or employee appointed by the City Council, except an ordinance proposed by citizen initiative petition, be adopted?*

The motion carried with Chair Benavidez, Vice Chair Rodriguez and Members Avery, Newberry, Norsell, and Ramirez voting aye, Member Mabon not voting, Member Burns voting no, and Members Clymer, Goldman, and McKeith absent.

Member McKeith joined the meeting during the following discussion.

CHARTER AMENDMENT - AUDITING, INVESTIGATION, AND RISK MANAGEMENT CONSOLIDATION INTO ONE CITY UNIT OVERSEEN BY AN INSPECTOR GENERAL - LOCAL GOVERNMENT AUDIT PRACTICES AND GUIDANCE

Following discussion, it was moved by Member Mabon and seconded by Member Newberry to move forward with the option of the job title to be Inspector General and the Inspector General be elected and have full subpoena powers as presented on August 18, 2021, by the Charter Review Committee. The motion carried with Chair Benavidez, Vice Chair Rodriguez and Members Avery, Burns, Mabon, McKeith, Newberry, Norsell, and Ramirez voting aye and Members Clymer and Goldman absent.

INVITATIONS TO COUNCILMEMBERS FOR DISCUSSION OF SUBSEQUENT RECOMMENDATIONS ON INSPECTOR GENERAL POSITION TO BE CONSIDERED FOR PLACEMENT ON NOVEMBER 2022 BALLOT

Following discussion and without formal motion, the Committee determined invitations to councilmembers for discussion of subsequent recommendations on Inspector General position to be considered for placement on November 2022 ballot would not be necessary.
