
ESTABLISH STRUCTURED ON-BOARDING PROCESS FOR ELECTED OFFICIALS

Following discussion, it was moved by Vice Chair Perry and seconded by Member Conder to (1) authorize the City Manager's Office to establish a structured onboarding process for elected officials as outlined in the staff report; and (2) direct staff to include in the orientation and required training processes: (a) facetime for newly elected officials with the Mayor and other current Councilmembers so that experiences can shared and questions answered at the same time; (b) travel guidelines; and (c) League of California Cities training.
