The motion carried unanimously.

SMOKE-FREE MULTI-UNIT FAMILY HOUSING POLICIES - PROPOSED ORDINANCE TO REGULATE SMOKE-FREE MULTI-UNIT HOUSING REQUIREMENTS

Following discussion, it was moved by Member Plascencia and seconded by Chair Perry to (1) receive and order filed a report on smoke-free Multi-unit Housing policies; and (2) recommend that City Council adopt the proposed ordinance to regulate smoke-free Multi-unit Housing in the City of Riverside.
