# PROFESSIONAL CONSULTANT SERVICES AGREEMENT WITH KTUA OF SAN DIEGO TO LEAD AN INCLUSIVE MULTI-DAY DESIGN CHARETTE AND COMMUNITY ENGAGEMENT PROGRAM FOR CITY-OWNED FAIRMOUNT GOLF COURSE

Following discussion, it was moved by Vice Chair Edwards and seconded by Member Hemenway to recommend (1)the City Council consider a proposal from KTUA to lead an inclusive multi-day design charette and community engagement program for the City-owned Fairmount Golf Course property; and (2) staff negotiate a Professional Consultant Services Agreement for Request for Proposal (RFP) No. 2119 with KTUA in the amount of \$185,378 to conduct a multi-day design charette process and community engagement program to determine whether there is a community vision for the Fairmount Golf Course that would be desirable as an alternative to its current use as a City operated public golf course and present to the City Council for final consideration and approval. The motion carried unanimously.

# DEVELOPMENT PROPOSAL FROM GRAPEVINE DEVELOPMENT, LLC FOR 2.12 ACRES OF SUCCESSOR AGENCY AND HOUSING AUTHORITY-OWNED VACANT LAND, LOCATED AT 2731-2871 UNIVERSITY AVENUE AND 2882 MISSION INN AVENUE

Following discussion, it was moved by Councilmember Cervantes and seconded by Member Hemenway to recommend (1) the City Council review and consider the development proposal from Grapevine Development, LLC for the Successor Agency and Housing Authority properties for the development of a mixed-use project; (2) staff to negotiate a Purchase, Sale, and Development Agreement for the Successor Agency property with Grapevine Development, LLC for the proposed development project to be presented to the Successor Agency Board, Oversight Board and Department of Finance for final consideration and approval; and (3) to negotiate a Disposition and Development Agreement for the Housing Authority Property for the proposed development project to be presented to the Housing Authority Board for final consideration and approval. The motion carried unanimously.
