COMMUNITY FACILITIES DISTRICT NO. 2015-2 (POMELO) - RESOLUTION

Hearing was called to consider adopting a Resolution authorizing the issuance of the Community Facilities District 2015-2 (Pomelo), Special Tax Bonds, Series 2022A (Tax Exempt) and 2022B (Federally Taxable) in an aggregate principal amount not-to-exceed \$6,000,000, approving the financing team, approving the form of acquisition agreement, and authorizing the execution and delivery of associated financing documents. No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Hemenway and seconded by Councilmember Perry to (1) adopt a Resolution authorizing the issuance of the Community Facilities District No. 2015-2 (Pomelo) Special Tax Bonds, Series 2022A (Tax Exempt) and 2022B (Federally Taxable) in an aggregate principal amount not-to-exceed \$6,000,000; (2) approve the financing team, as identified in the staff report, for this transaction and authorize the City Treasurer or any duly authorized designee, to pay the costs of such firms in connection with this financing from CFD 2015-2 Series 2022A and 2022B bond proceeds; and (3) approve the form of Acquisition Agreement between the City of Riverside, and Friends of the Airport, LLC; and (4) authorize the City Manager and Chief Financial Officer, or designees, to execute all documents related to the issuance of the Special Tax Bonds for Community Facilities District No. 2015-2 (Pomelo) and the ability to make minor changes to these documents as required to carry out the financing. The motion carried unanimously.

Whereupon, the title having been read and further reading waived, Resolution No. 23849 of the City Council of the City of Riverside, California, Acting as the Legislative Body of Community Facilities District No. 2015-2 (Pomelo) of the City of Riverside, Authorizing the Issuance of its Special Tax Bonds, Series 2022A (Tax Exempt) and Special Tax Bonds, Series 2022B (Federally Taxable) in an Aggregate Principal Amount Not to Exceed Six Million Dollars (\$6,000,000) in One or More Series of Bonds and Approving Certain Documents and Taking Certain Other Actions in Connection Therewith, was presented and adopted.

Seq., for the Riverside Police Department, was presented and introduced.

## SMOKING REGULATIONS FOR MULTI-UNIT RESIDENCES THROUGHOUT CITY - ORDINANCE INTRODUCED
