
Following discussion, it was moved by Vice Chair Hemenway and seconded by Member Perry (1) to receive and order filed the street paving and resurfacing projects update; and (2) recommending that the City Council extend the paving moratorium from three years to five years to better support the Pavement Management Program. The motion carried unanimously.

COMMUNICATIONS

PROJECT UPDATES

Deputy Public Works Director Mustafa provided project updates to the Committee including the (1) requested pavement contractor and material report is anticipated for the July Committee meeting; (2) Martin Luther King Sewer line with project anticipated for completion in the Fall including a segment on Canyon Crest Drive and UCR is being updated on progress and impacts; (3) Orange Street (University Avenue to 14th Street) paving project has commenced, project will include the first diagonal crosswalk, and paving University Avenue between Ottawa Ave and Iowa Avenue will also begin; (4) Van Buren Sewer Project - Bid 7918 anticipated to be advertised by the end of this month; (5) Woods Streets Phase I Sewer Project - Bid 7913 anticipated to be advertised by the end of this month; (6) Third St Grade Separation Project; (7) zero delayed solid waste routes to service; (8) Public Works and Parks and Recreation are preparing to submit between \$20 and \$25 million in Active Transportation Grant fund requests for a range of projects; (9) Traffic Engineering Division completion of SB1 traffic safety project, which includes a new signal at Arlington & Stover, new edge lit LED stop signs, new speed feedback signs including an overhead sign on Trautwein, and new bike lanes; (10) Parking Services team will be bringing a bid award recommendation to the City Council in June that will modernize technology at three downtown garages this coming fiscal year; and (11) Deputy Director Ed Filadelfia with our Wastewater Division will be bringing to this committee's July meeting an overview of Wastewater's renewable energy plan, which includes plans for generating clean energy using food waste.
