### CONSENT CALENDAR

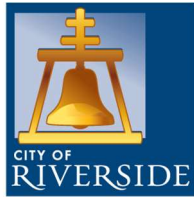

### REQUEST FOR BID 7900 - THREE-YEAR SUPPLY OF 19 PERCENT AQUEOUS AMMONIA - RIVERSIDE ENERGY RESOURCE CENTER (RERC), CLEARWATER AND SPRINGS POWER PLANTS

The Board of Public Utilities awarded Request for Bid 7900 to Airgas Specialty Products, Inc., Lawrenceville, Georgia, for a three-year supply of 19 percent aqueous ammonia for the Riverside Energy Resource Center, Clearwater and Springs Power Plants for term ending on July 1, 2025, for \$99,300.

### REQUEST FOR PROPOSAL 2159 AND AGREEMENT - WATER QUALITY LABORATORY TESTING AND ANALYTICAL SERVICES

The Board of Public Utilities (1) approved the expenditure of \$3,000,000 for Request for Proposal 2159 for water quality laboratory testing and analytical services, for a three-year term in the amount of \$3,000,000 plus two optional one-year extensions in an annual amount of \$1,000,000; and (2) recommended that the City Council approve a Professional Consultant Services Agreement with Eurofins Eaton Analytical, LLC, Monrovia, California, from Request for Proposal 2159 for water quality laboratory testing and analytical services for a three-year term in the amount of \$3,000,000 plus two optional one-year extensions in an annual amount of \$1,000,000.

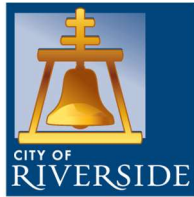
### WORK ORDER 2225922 AND SUPPLEMENTAL AGREEMENT - PREPARATION OF CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) DOCUMENTATION AND TITLE 20 CERTIFICATE OF APPROPRIATENESS (COA) - PHASE 2 OF CITYWIDE STREETLIGHT LIGHT EMITTING DIODE (LED) CONVERSION PROGRAM

The Board of Public Utilities (1) approved the capital expenditure for Work Order 2225922 in the amount of \$119,000, which includes project management and services agreement change order authority costs, for preparation of California Environmental Quality Act documentation and Title 20 Certificate of Appropriateness for Phase 2 of the Citywide Streetlight LED Conversion Program; and (2) recommended that the City Council approve a Supplemental Agreement with TRC Solutions, of Irvine, California, from Request for Proposal 2160 for preparation of California Environmental Quality Act documentation and Title 20 Certificate of Appropriateness for Phase 2 of the Citywide Streetlight LED Conversion Program in the amount of \$68,400.


PUBLIC UTILITIES 2022 WILDFIRE MITIGATION PLAN FOR SUBMITTAL TO WILDFIRE SAFETY ADVISORY BOARD IN ACCORDANCE WITH CALIFORNIA PUBLIC UTILITIES CODE SECTION 8387  
Following discussion, it was moved by Member Oceguela and seconded by Member Wohlgemuth to approve the Riverside Public Utilities 2022 Wildfire Mitigation Plan, Version 2, for submittal to the Wildfire Safety Advisory Board in accordance with California Public Utilities Code Section 8387. The motion carried unanimously with Members Gujral and Melendez absent.

EXPENDITURES FOR ANNUAL PURCHASE ORDERS, EXISTING CONTRACT PURCHASE ORDERS, ANNUALLY RECURRING EXPENDITURES OVER \$50,000 AND PURCHASE ORDERS WITH MULTI-YEAR COST OVER \$50,000 FOR FISCAL YEAR 2022-2023

Following discussion, it was moved by Member Oceguela and seconded by Member Wohlgemuth to approve (1) the expenditure for 14 Fiscal Year 2022-2023 Annual Purchase Orders for Electric and Water operations, with an estimated amount of \$2,969,114; (2) the expenditure for 22 Fiscal Year 2022-2023 Annual Purchase Orders for Central Stores for orders benefiting Electric and Water operations, with an estimated amount of \$17,025,672; (3) a not to exceed 30 percent allowance for Producer Price Index (PPI) increases for 22 Fiscal Year 2022-2023 Annual Purchase Orders for Central Stores for orders benefiting Electric and Water operations; (4) the expenditure for 42 Fiscal Year 2022-23 Existing Approved Contract-related Purchase Orders for Fiscal Year 2022-2023 with an estimated total amount of \$8,247,401; (5) the expenditure for 12 Fiscal Year 2022-2023 Annually Recurring Expenditures for SHARE, memberships and subscription expenses that are either greater than \$50,000 per year or could, over a number of years, cumulatively exceed \$50,000 for multi-year expenses, with an estimated total amount of \$3,292,339; and (6) the expenditure for 63 Fiscal Year 2022-2023 Purchase Orders with cumulative multiple year costs equal to or greater than \$50,000 with an estimated total amount of \$2,375,127. The motion carried unanimously with Members Gujral and Melendez absent.
