The Mayor and City Council reconvened at 6:15 p.m. with Mayor Lock Dawson presiding and all Councilmembers present except Councilwoman Plascencia.

Councilmember Conder gave the Invocation and led the Pledge of Allegiance.

MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Edwards reported on Ward 1 Office hours, 4th of July Fireworks Show at Bonaminio Park, Miracles and Dreams Foundation annual backpack drive on July 9th, and thanked Parks and Neighborhood Specialists for assisting with the Inland Empire Kids Outdoors Camp. Councilmember Cervantes reported on Riverside Pride Gala, seeking volunteers to pick produce at the University of California, Riverside community garden, Townhall meeting on the Eastside collaborative and housing, free swim days, and thanked the Fire Team for their response to a local fire. Councilmember Fierro reported on Western Riverside Council of Governments (WRCOG) General Assembly Conference. Councilmember Conder reported on WRCOG General Assembly Conference, New Joy Baptist Church Family and Friends Day, and Concert for Heroes at the National Cemetery. Councilmember Hemenway reported on The Gardens of Riverside memory care facility recognizing Stephanie Oden for her advocacy with Alzheimer, movie night at the park, and Firework Show at La Sierra Park. FIVE-YEAR PLAN TO REDUCE HOMELESSNESS - 2021-2022 UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT ANNUAL ACTION PLAN AMENDMENT - SUPPLEMENTAL APPROPRIATION

Hearing was called to review and provide input to the draft Five-Year Plan to Reduce Homelessness, including the Homeless Housing, Assistance and Prevention-3 and HOME Investment Partnerships-American Rescue Plan regional outcome goals required and HOME Investment Partnerships Program-American Rescue Plan allocation plan; and approve a Substantial Amendment to the City of Riverside 2021-2022 United States Department of Housing and Urban Development Annual Action Plan for the allocation of \$4,335,583 of HOME Investment Partnerships Program- American Rescue Plan grant funds. Five people spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Edwards and seconded by Councilmember Cervantes to (1) review the Five-Year Plan to Reduce Homelessness, including the Homeless Housing, Assistance and Prevention-3 and HOME Investment Partnerships-American Rescue Plan regional outcome goals as required by the State of California Interagency Council on Homelessness; (2) approve a Substantial Amendment to the City of Riverside 2021-2022 United States Department of Housing and Urban Development Annual Action Plan for the allocation of \$4,335,583 of HOME Investment Partnerships Program-American Rescue Plan grant funds; (3) adopt the HOME Investment Partnerships Program-American Rescue Plan allocation plan required by the United States of Housing and Urban Development HOME Investment Partnerships Program-American Rescue Plan regulations; and (4) direct the Office of Homeless Solutions work with the Communications Department for readability and flow of the draft 5 Year Plan to Reduce Homelessness incorporating feedback from the public and Councilmembers for review by the Homelessness Task Force particularly looking at experts in evaluation and final draft to be presented to the Housing and Homelessness Committee in September 2022, and to the full City Council in October 2022. The motion carried with Councilmembers Edwards, Cervantes, Fierro, and Hemenway voting aye, Councilmembers Conder and Perry voting no, and Councilwoman Plascencia absent.

Following further discussion, it was moved by Councilmember Edwards and seconded by Councilmember Cervantes, with at least five affirmative votes, to authorize an increase in revenue and an appropriation in expenditures in the amount of \$4,335,583 in the HOME Investment Partnership Program Fund, HOME Investment Partnership Program. The motion failed for lack of five affirmative votes with Councilmembers Edwards, Cervantes, Fierro, and Hemenway voting aye, Councilmembers Conder and Perry voting no, and Councilwoman Plascencia absent.

PARTICIPATE IN STATE OF CALIFORNIA'S HOMEKEY PROGRAM - 22-UNIT PERMANENT SUPPORTIVE HOUSING DEVELOPMENT PROJECT - 11049 BOGART - RESOLUTION The City Council (1) adopted a resolution supporting the Sunrise at Bogart, a 22-unit affordable and permanent supportive housing community located at 11049 Bogart Street by Neighborhood Partnership Housing Services, Inc., for the project's Homekey Program funding application to the State of California to increase the funding request to \$4,400,000; (2) authorize the Chief Financial Officer, or designee, to record an increase in revenues and supplemental appropriation in an amount up to \$4,400,000, or in the amount of the grant award, in the Development Grants Fund, Homekey Program accounts; and (3) authorized the City Manager, or designee, to execute a Homekey Grant Agreement with Sunrise at Bogart LP, including making minor and non-substantive changes; whereupon, the title having been read and further reading waived, Resolution No. 23872 of the City Council of the City of Riverside, California, Authorizing Application

AGREEMENT AMENDMENT - FINANCIAL ADVISORY SERVICES

The City Council (1) approved the Second Amendment to the Master Professional Consultant Services Agreement with NHA Advisors, LLC., to extend the term to June 30, 2023; and (2) authorized the City Manager, or their designee, to execute the Amendment with NHA Advisors, LLC., including making minor and non-substantive changes.

The City Council (1) approved the purchase and delivery of fuel products for City of Riverside vehicles and equipment with SC Commercial, LLC, Orange, in the total amount of \$2,437,727 for Fiscal Year 2022-2023; (2) approved four one-year renewal periods with SC Commercial, LLC, for the purchase and delivery of fuel products in the amounts of \$2,681,499 for Fiscal Year 2023-2024, \$2,949,649 for Fiscal Year 2024-2025, \$3,244,614 for Fiscal Year 2025-2026, and \$3,569,075 for Fiscal Year 2026-2027 inclusive of 10 percent annual increases for future fuel market volatility; and (3) authorized the City Manager, or designee, to execute all documents pursuant to this purchase including making minor and non-substantive changes, and annual renewal extensions.
