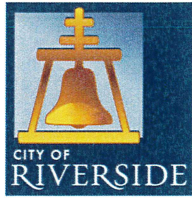

There was no one wishing to address the Committee.

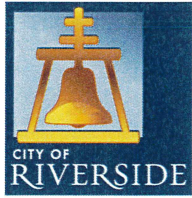
### RESHAPE RIVERSIDE REDISTRICTING UPDATE

Following discussion and without formal motion, the Committee received and ordered filed an update on the Reshape Riverside Redistricting Plan.

### OPTIONS TO EXPAND LANGUAGE ACCESS FOR LIMITED ENGLISH PROFICIENCY PERSONS THROUGH SPANISH TRANSLATION OF CITY COUNCIL AND COMMITTEE MEETING BROADCASTS AND AGENDAS

Following discussion, it was moved by Chair Cervantes and Vice Chair Perry to (1) expand language access for Limited English Proficiency persons through the Spanish translation of City Council and Committee meeting agendas; (2) expand language access for Limited English Proficiency persons through automated Spanish captions of City Council and Committee meetings; (3) provide in-person interpretation options for City Council and Committee meetings; and (4) direct staff to refer any language access and translation service recommendations selected to the full City Council for discussion. The motion carried with Member Conder abstaining.

### CITY COUNCIL RULES OF PROCEDURE AND ORDER OF BUSINESS REVIEW REGARDING NUMBER AND ROLE OF BOARDS AND COMMISSIONS UPDATE

Following discussion, it was moved by Chair Cervantes and Vice Chair Perry to (1) request staff bring forth recommended language for a separate resolution addressing the purview and reporting structure of Boards and Commissions; (2) introduce Model Deaf Community as an official commission by ordinance or resolution; (3) include the role of staff when working with Boards and Commissions; and (4) request staff bring forth any specific language recommendations along with a corresponding resolution to the full City Council for discussion. The motion carried unanimously.
