REQUEST FOR PROPOSAL 2218 - AGREEMENT - FESTIVAL OF LIGHTS EVENT SECURITY **SERVICES**

The City Council (1) approved the Services Agreement with American Global Security, Chatsworth, to provide event security services for the 2022 Festival of Lights in an amount not-to-exceed \$197,680 for a term ending on January 31, 2023; and (2) authorized the City Manager, or his designee, to execute the Services Agreement with American Global Security, including making minor and non-substantive changes.

CASE PR-2022-001346 - ELECTRIFIED SECURITY FENCE SYSTEMS IN INDUSTRIAL ZONES -**ORDINANCE - CONTINUED**

This item was continued to the City Council meeting on December 6, 2022.

CALIFORNIA DEPARTMENT OF WATER RESOURCES URBAN COMMUNITY DROUGHT RELIEF GRANT PROGRAM - PUBLIC UTILITIES' RIVERSIDE HABITAT, PARKS, AND WATER PROJECT -**RESOLUTION**

The City Council (1) adopted a resolution authorizing the submittal of a grant application to the Department of Water Resources Urban Community Drought Relief Grant Program for Riverside Public Utilities' Riverside Habitat, Parks, and Water Project in the estimated amount of \$25,000,000; (2) authorized the City Manager, or designee, to accept the amount awarded and execute all grant documents, including making minor and nonsubstantive changes to documents associated with the grant; and (3) with at least five affirmative votes, and upon grant award, authorized a supplemental appropriation and recording of revenue in the amount of the grant award in the Water Fund, Urban Community Drought Relief Project; whereupon, the title having been read and further reading waived, Resolution No. 23922 of the City Council of the City of Riverside, California, Authorizing the City Manager to Execute on Behalf of the City of Riverside All Necessary Applications, Contracts, Payment Requests, Agreements and Amendments in The Process of Applying for and Securing Funds Under the California Department of Water Resources Urban Community Drought Relief Grant Program, was presented and adopted.

AGREEMENT - MAINTENANCE OF DOWNTOWN AREA WATER FEATURES ON MAIN STREET MALL

The City Council (1) approved a Services Agreement for Maintenance of Downtown Area Water Features Located on Main Street Mall with Service First, Santa Ana, California, for a term through June 30, 2025, in the amount \$136,000 for the initial term, with the option

to extend for two additional one-year terms; (2) authorized the City Manager, or designee, to execute the Services Agreement, including making minor and non-substantive changes; and (3) authorized the City Manager, or designee, to execute two optional one-year term extensions to the Services Agreement provided that the annual amounts are included in the approved budget.

SPEED LIMIT ZONE - CALMHILL/CALIFORNIA/CHALLEN AVENUES - WASHINGTON/ SUNDANCE TRAIL - ORDINANCE ADOPTED

The City Council adopted an Ordinance amending Section 10.76.010 of the Riverside Municipal Code designating the Prima Facie Speed Limits for streets and portions thereof in accordance with the provisions of Sections 10.20.020 and 10.20.030, for establishment of 25 mph speed limit zone on Calmhill Drive from California to Challen Avenues and 30 mph speed limit zone on Frances Street from Washington Street to Sundance Trail, whereupon the title having been read and further reading waived, Ordinance No. 7610 of the City of Riverside, California Amending Section 10.76.010 of the Riverside Municipal Code Designating the Prima Facie Speed Limits for Streets and Portions Thereof in Accordance with the Provisions of Sections 10.20.020 And 10.20.030, was presented and adopted.

2023 DOWNTOWN PARKING AND BUSINESS IMPROVEMENT AREA ANNUAL ASSESSMENT - RESOLUTION

Hearing was called to hear and rule on any protests to the annual assessment proposed for the Riverside Downtown Parking and Business Improvement District for Calendar Year 2023 and adopt a Resolution confirming the annual report of the Riverside Downtown Partnership, acting as the advisory board to the Riverside Downtown Parking and Business Improvement District, and levying assessments for Calendar Year 2023. One person spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Edwards and seconded by Councilmember Conder to (1) adopt a Resolution confirming the annual report of the Riverside Downtown Partnership, acting as the advisory board to the Downtown Parking and Business Improvement Area and levying assessments for Calendar Year 2023; and (2) direct the Riverside Downtown Partnership to expend revenues derived from the Riverside Downtown Parking and Business Improvement Area annual assessment and to operate the programs and activities in accordance with Chapter 3.46 of the Riverside Municipal Code and the annual report. The motion carried with Councilmembers Edwards, Cervantes, Conder, Perry, Hemenway and Councilwoman Plascencia voting aye and Councilmember Fierro recused.

Whereupon, the title having been read and further reading waived Resolution No. 23923 of the City Council of the City of Riverside, California, Confirming the Annual Report of the Riverside Downtown Partnership Acting in its Capacity as the Advisory Board to the Downtown Parking and Business Improvement Area and Levying Assessments for Calendar Year 2023, was presented and adopted.

ISSUANCE OF 2022A WATER REVENUE BONDS - INTEREST RATE MODE CONVERSION AND REMARKETING OF 2011A - RESOLUTIONS

Hearing was called to consider approving the issuance of up to \$70 million of Water Revenue Bonds to finance identified Water Utility capital projects and to pay bond issuance, along with the interest rate mode conversion and remarketing of \$24.05 million 2011A Variable Rate Refunding Water Revenue Bonds to be supported by a Letter of Credit issued by PNC Bank, National Association. No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Perry and seconded by Councilwoman Plascencia to (1) approve the City's Financing Team for the transactions and authorize the Chief Financial Officer/City Treasurer or any duly authorized designee to pay the costs of such firms in connection with the interest rate reset and tender, purchase and remarketing of the 2011A Bonds from the City's Water Fund and the costs of the firms in connection with the new money issuance of the 2022A Water Revenue Bonds from bond proceeds; (2) adopt a resolution authorizing the issuance of the 2022A Water Revenue Bonds in an aggregate principal amount not-to-exceed \$70 million; (3) adopt a resolution authorizing certain actions related to an unscheduled mandatory tender, interest rate mode conversion and remarketing of the previously authorized and currently outstanding 2011A Bonds, including approval of a Reimbursement Agreement and Fee Letter with PNC Bank, National Association, and Remarketing Statement for the 2011A Bonds; and (4) upon closing of the 2022A Water Revenue Bonds, authorize the Chief Financial Officer/City Treasurer, or designee to make the necessary budget adjustments and/or appropriations to properly record the refunding and financing expenses in accordance with governmental accounting standards. The motion carried unanimously.

Whereupon, the titles having been read and further readings waived, Resolution No. 23924 of the City Council of the City of Riverside, California Authorizing the Issuance of Water Revenue Bonds of the City in an Aggregate Principal Amount Not to Exceed \$70,000,000 and Providing the Terms and Conditions of Such Bonds (Eleventh Supplemental Resolution); and Resolution No. 23925 of the City Council of the City of Riverside, California, Authorizing Certain Actions Related to an Interest Rate Mode Conversion and Remarketing of the Previously Authorized and Issued Variable Rate Refunding Water Revenue Bonds, Issue of 2011A, were presented and adopted.
