REVIEW OF 2022 BY-LAW AD HOC COMMITTEE RECOMMENDATIONS

UPDATES FROM THE CITY MANAGER'S OFFICE

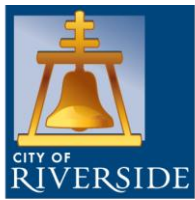
Interim Assistant City Manager/Chief Financial Officer/City Treasurer Edward Enriquez reported the following City Council items associated with RPD:

September 6, 2022:

- (1) Procurement process waiver to authorize the purchase of new and used vehicles in an amount not to exceed Measure Z funding of \$1,700,000
- (2) Increase to annual Purchase Order 230058 with Heli-Mart, Inc. in the amount of \$221,316 and Purchase Order 230093 with H.E.R.O.S., Inc. in the amount of \$119,257 for repair and maintenance of Police helicopters.
- (3) Resolution to renew the \$10,000 reward offer for information leading to the determination of the identify of, and the apprehension of, the person or persons responsible for the recent home invasion robberies at the 14100 block of Ashton Lane, the 18400 block of Moss Road, and the 1500 block of Kyle Court.

September 20, 2022

- (1) Council received a report on the Police vehicle upfitting process
- (2) Approval of the Riverside Police Administrators' Associated Memorandum of Understanding effective January 1, 2022 through December 31, 2023
- (3) Memorandum of Understanding with Riverside Unified School District in the amount of \$2,126,620 including a City match of \$1,063,310 from the Riverside Police Department Biennial Budget for the School Resource Officer Program through June 30, 2024.
- (4) Memorandum of Understanding with Alvord Unified School District in the amount of \$1,275,972 including a City match of \$637,986 annually from the Police

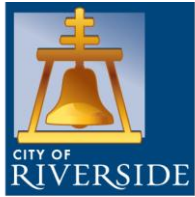
ITEMS FOR FUTURE CONSIDERATION AS REQUESTED BY COMMISSION MEMBERS OR CPRC MANAGER

Chair Teichert reiterated her request to have a presentation from the Riverside Police Department on the Racial Identity Profiling Act report.

Commissioner DeBrier requested a future item be brought to the Commission for discussion to prepare a proposal to request the City of Riverside host the 2025 Annual NACOLE Conference. He also requested to make a brief presentation at the next CPRC Meeting outlining the updates to presentation materials and website information.

CPRC Manager Megan Stoye advised Commissioners that the City Manager's Office has been working with the Inclusiveness, Community Engagement, and Governmental Processes Committee (ICGC) to review Resolution 23618, which identifies the rules and procedures for Council to follow. ICGC has requested to review the roles of the City of Riverside Boards and Commissions separately. She will advise when the discussion pertaining to CPRC is brought to ICGC. She also requested the City Attorney's Office present regarding the recently passed Assembly Bill 2449, which revises the Brown Act in relation to teleconference participation.

Commissioner DeBrier also requested the Riverside Police Department make a future presentation to the Commission to report on Officer Involved Deaths (OID) incidents. Frank Hauptmann advised that a report will be forthcoming regarding a report in progress. Captain Payne reported that there has only been one (1) OID year-to-date, which was previously briefed to the Commission by Chief Larry Gonzalez.
