

**FOURTH AMENDMENT TO

THIS FOURTH AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Fourth Amendment") is made and entered into this _____ day of _____, _____, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and T.Y. LIN INTERNATIONAL, a California corporation ("Consultant"), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated August 22, 2019 ("Agreement") for SR-91/Adams Street Interchange Reconfiguration, Federal Aid Project No. STPL-5058 (094); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement dated July 27, 2020 ("First Amendment") to amend the Scope of Services and add additional Compensation in the amount of Fifty-Two Thousand Eight Hundred Ninety-Five Dollars (\$52,895.00); and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement dated September 14, 2023 ("Second Amendment") to extend the Term of the Agreement to August 22, 2025; and

WHEREAS, the City and Consultant entered into that certain Third Amendment to Professional Consultant Services Agreement dated August 12, 2024 ("Third Amendment") to add additional Compensation in the amount of One Hundred Sixty-Three Thousand Four Hundred Twenty-Six Dollars (\$163,426.00); and

WHEREAS, the Agreement is set to expire August 22, 2025; and

WHEREAS, the City and Consultant desire to extend the Term of the Agreement for an additional three (3) years, through August 22, 2028.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. The Term of the Agreement is hereby extended for an additional three (3) years, through August 22, 2028.

2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Fourth Amendment, shall remain in full force and effect as if fully set forth herein.
